## Feiten

Apple heeft kwetsbaarheden verholpen in iOS 26.1 en iPadOS 26.1.

## Duiding

De kwetsbaarheden betroffen verschillende privacy- en beveiligingsproblemen, waaronder ongeautoriseerde toegang tot gebruikersgegevens, het risico van gegevensfiltratie, en kwetsbaarheden in geheugenbeheer die konden leiden tot onverwachte systeemcrashes. Aanvallers konden mogelijk gevoelige informatie verkrijgen via misbruik van deze kwetsbaarheden, wat de integriteit en privacy van gebruikers in gevaar bracht. De updates bevatten verbeterde validatiemechanismen en restricties om deze risico's te mitigeren.

## Oplossingen

Apple heeft updates uitgebracht om de kwetsbaarheden te verhelpen. Zie bijgevoegde referenties voor meer informatie.
